PROPOSED CHANGE: ADD THE LETTER "W" TO THE RPV FLAG LIST. THE "W" WILL INDICATE THE RPV COST WAS DEVELOPED USING THE RS MEANS COSTWORKS SOFTWARE. THIS SOFTWARE DEVELOPS RPV ESTIMATES FOR BUILDINGS, TRAILERS AND OSFs AND CONDITION INDEX CALCULATIONS IN THE CAIS SOFTWARE. COSTWORKS HAS 76 BUILDING MODELS THAT CAN BE CUSTOMIZED AND OVER 1000 ASSEMBLIES FOR ESTIMATING OSF REPLACEMENT COSTS.

JUSTIFICATION: MANY SITES ARE USING THE COSTWORKS SOFTWARE FOR ESTIMATING THEIR RPVs, ANNUAL REQUIRED MAINTENANCE ESTIMATES, AND SUSTAINMENT COSTS AND IN THE NEXT RELEASE MAINTENANCE ESTIMATES FOR THEIR TYSPs. FIMS HAS FIELDS FOR THE RPV MODEL NUMBER AND NAME THAT ARE IN COSTWORKS. COSTWORKS CONTAINS ALL RS MEANS COSTBOOKS AND PERMITS INTERACTIVE CUSTOMIZATION OF THE FIMS MODELS. IT ALLOWS THE USERS TO ALTER THE MODELS FOR GSF AND LINE ITEM SPECIFICATIONS. THIS TOOL UPDATES AND ENHANCES EXISTING MODELS IN FIMS.

HAVING THE "W" IN THE RPV FLAG LIST WILL INDICATE THAT THE FIMS MODELS HAVE BEEN CUSTOMIZED USING COSTWORKS TO MEET THE ACTUAL SPECIFICATIONS OF THE EXISTING BUILDING, TRAILER OR OSF. KNOWING THE MODELS HAVE BEEN CUSTOMIZED THE PROGRAM OFFICES HAVE CONFIDENCE IN THE QUALITY, CONSISTENCY AND ACCURACY OF THE RPV ESTIMATES.
