Change the Total No of Occupants to a system generated field. This field will be the sum of the Total Number of Federal Employees, Total Number of Contractor Employees and Total Number of Other Personnel. This eliminates the need for Site to populate this data element. As a result of this change, the three occupancy fields will now be required regardless of usage code for buildings and trailers. This includes DOE Owned, DOE Leased, Contractor Leased, GSA Owned and GSA

	<p>Leased buildings and trailers assets.</p> <p>2. Delete Deficiency data elements 1 – 5 for buildings and OSF's. These are no longer needed with the addition of the Unifomat Repair Needs information on the LOB Condition window. Removing these fields eliminates duplication.</p>
Justification:	Data elements that no longer have a driving need to remain in FIMS and that are not supported by the Headquarters Program Offices must be removed from FIMS. This reduces the burden on the Sites who must populate the information in FIMS. In addition, this allows us to reduce the IT burden by maintaining data points in the database that are no longer needed.
