SUBJECT: Facilities Information Management System (FIMS) Version 1.36 Release

Today, Thursday, November 4, 2010, version 1.36 of the Facilities Information Management System (FIMS) was released. This release addresses the following enhancement which will automatically be available to you when you log into FIMS from your browser.

- Implementation of Change Request 10-07. As a result of this Change Request, the Occupant window as well as the following data elements have been removed.
  - Occupant Indicator (Building Info, Trailer Info)
  - Occupant ID (Occupant Window)
  - Occupant Name (Occupant Window)
  - Occupant Type (Occupant Window)
  - No of Employees (Occupant Window)
- Add a new field called **Total No of Occupants** (to replace the No of Employees field) to the Property Detail window. This field has automatically been populated with the sum of the No of Employees field from the now deleted Occupant window. This field has been designated as a required field and will continue to be a part of FIMS data validation process. If a building or trailer is unoccupied, the value of 0 would be input into this field.
- Implementation of Change Request 10-11. As a result of this Change Request, the following data elements have now been removed from FIMS.
  - Modernization Planning Indicator (Maintenance window)
  - Rehab and Improvement Cost (Maintenance window)
- The following FIMS standard reports have now been removed.

  - 125 – Building Summary TRIC and TSCI Report
  - 126 – Building GP/C and Programmatic Summary Report
