PROPOSED CHANGE: MAKE THE FOLLOWING DATA ELEMENT CHANGES IN FIMS.

- REMOVE THE UFAS COMPLIANCE, EXEMPTION, AND JUSTIFICATION DATA ELEMENTS FROM THE BUILDING AND TRAILER INFO WINDOWS. THESE FIELDS ARE AVAILABLE FOR DOE OWNED BUILDINGS AND TRAILERS. DO NOT REMOVE THE DATA ELEMENTS FROM THE DATABASE.
- DELETE THE ESCALATION YEAR SERVICES, OTHER, AND TAXES FROM THE INGRANT 2 WINDOW FOR DOE AND CONTRACTOR LEASES. THESE ELEMENTS SHOULD BE REMOVED FROM THE DATABASE.
- DELETE THE TRANSFER TO PSO FIELD FROM THE PROPERTY DETAIL WINDOW FOR ALL ASSETS. THIS ELEMENT SHOULD BE REMOVED FROM THE DATABASE.
- DELETE THE LANDLORD FUNDING PROGRAM FROM THE SITE INFO WINDOW. THIS ELEMENT SHOULD BE REMOVED FROM THE DATABASE.

JUSTIFICATION: BASED ON A LENGTHY DISCUSSION AT THE RECENT WORKSHOP, IT WAS DETERMINED THAT THESE FIELDS ARE NOT BEING UTILIZED BY THE USER COMMUNITY AND THEREFORE SHOULD BE REMOVED FROM FIMS. IN ADDITION, THE HEADQUARTERS SPONSORS INDICATED THEY HAVE NO FURTHER USE FOR THESE FIELDS. RETAINING THESE FIELDS IN FIMS PLACES AN ADDITIONAL BURDEN ON ALL SITES TO MAINTAIN THEM. THERE DOES NOT APPEAR TO BE ANY VALUE IN RETAINING THEM.

AS FOR THE UFAS FIELDS, WE COULD NOT REACH A CONSENSUS AT THE WORKSHOP AS TO WHETHER OR NOT THESE SHOULD BE PERMANENTLY REMOVED FROM FIMS BUT MOST AGREED THEY WERE NOT USING THEM ON ANY SORT OF BASIS BUT THERE COULD BE A FUTURE USE. IT WAS DECIDED THEY WOULD BE REMOVED FROM THE SCREEN AND THEIR USEFULNESS WOULD BE REASSESSED AT A LATER DATE.
